

# LCF NUESTRO FUTURO FUND ORGANIZATIONS ON THE FRONTLINES

To date, LCF has identified several organizations that are trusted community anchors that are equipped to take on the necessary action to protect, defend, and serve DACA youth. LCF will prioritize organizations serving youth and families in the Central Valley region. Below are a few examples of the types of organizations LCF will seek to support.



**67 SUEÑOS** educates and empowers undocumented youth to lead their own advocacy campaigns through art, media and culture. Youth learn organizing and advocacy skills, lead campaigns, and participate and coordinate community actions.



**CALIFORNIA IMMIGRANT YOUTH JUSTICE ALLIANCE** is a civic engagement and advocacy organization that trains and coordinates diverse immigrant youth led organizing efforts in California.



**CALIFORNIA RURAL LEGAL ASSISTANCE FOUNDATION** provides community outreach, educational training, and direct legal services to farmworker and migrant communities throughout California.



**CENTRAL VALLEY IMMIGRANT INTEGRATION COLLABORATIVE (CVIIC)** serves as the leading immigrant integration organization in the Central Valley, dedicated to ensuring full participation of immigrants in building strong, vibrant, inclusive communities.



**CENTRO BINACIONAL PARA EL DESARROLLO INDIGENA OAXAQUEÑO** implements projects for indigenous migrant communities that focus on worker's rights, professional development, indigenous interpreters, gender equality, access to health and social services, and community development.



**CENTRO LA FAMILIA ADVOCACY SERVICES** serves community members through outreach and education programs, and workshops that address crime victims, health inequities, and civic engagement.



**CENTRO LEGAL DE LA RAZA** is a comprehensive legal services agency protecting and advancing the rights of immigrant, low-income and Latino communities through bilingual legal representation, education, and advocacy. By combining quality legal services with know-your-rights education and youth development, they promote access to justice for thousands of individuals and families each year throughout the East Bay region of Northern California.



**COALITION FOR HUMANE IMMIGRANT RIGHTS (CHIRLA)** is a California leader with national impact made of diverse immigrant families and individuals who act as agents of social change to achieve a world with freedom of mobility, full human rights, and true participatory democracy. CHIRLA organizes and serves individuals, institutions and coalitions to build power, transform public opinion, and change policies to achieve full human, civil and labor rights.



**COMMUNITY LEGAL SERVICES OF EAST PALO ALTO** provides legal services to Palo Alto's most marginalized residents. Services range from advice, counseling, brief services, and full representation.

**DOLORES HUERTA FOUNDATION** creates a network of organized, healthy communities pursuing social justice through systemic and structural transformation.



**DREAMERS ROADMAP** is a national nonprofit app that helps undocumented students find scholarships to go to college. This organization brings hope to all those students who think there is no path for them after high school to continue their higher education.



**EDUCATION AND LEADERSHIP FOUNDATION** is a community benefit non-profit organization that strives to provide services to low-income families and students, such as: tutoring, mentoring, scholarships, internships and leadership development. They also provide immigration assistance, health education awareness and volunteer opportunities.



**EDUCATORS FOR FAIR CONSIDERATION** empowers undocumented young people to achieve educational and career goals through personal, institutional and policy transformation.



**ESPERANZA IMMIGRANT RIGHTS PROJECT** defends and advocates for immigrants as they navigate the complex immigration system. They provide different services to clients under the Community Education Program, the Direct Representation Program, the Pro Bono Program, and the Affordable Services Program.



**FAITH IN THE VALLEY** advances a movement for racial, economic, and environmental justice in local communities by building skills and leadership capacity of low income immigrant families and local communities.



**FRESNO IMMIGRANT YOUTH IN ACTION (FIYA)** is an undocumented youth-led organization that empowers immigrant youth and college-aged young adults to advocate for immigrant rights through art, local meetings, leadership summits, and community presentations.



**RADIO BILINGUE** counters inequities in access to Spanish-Language news and public affairs programs by operating 12 full-power FM non-commercial stations and a 24-hour national satellite content service to produce the first daily national Spanish-Language news public broadcasting.



**SERVICES, IMMIGRANT RIGHTS, AND EDUCATION NETWORK (SIREN)** empowers low-income immigrants and refugees through community organizing, leadership development, policy advocacy and naturalization services. SIREN elevates the voices of Latino families and ensures that there are essential services and protections for all regardless of citizenship status.



**UFW FOUNDATION** creates access to credible immigration legal advice and educational outreach with the intent to engage farmworkers and Latinos in the democratic process.



**UNITED WE DREAM** is the largest immigrant youth-led organization in the nation that empowers youth immigrants to advocate for their dignity.
